The challenge is open to local teams, as well as, GBA team members besides the Pitmasters. For example, a 3-person GBA team could have each team member to enter separately.

Brisket must be cooked on any type grill/smoker including charcoal, wood, or pellet. Turn in container will be provided. There shall be nothing in the container except the brisket. No garnish, gravy, topping, etc. of any kind is allowed. The brisket will be judged using the standard GBA comparative judging procedures.
